**WE ONLY ISSUE TIP'S FOR NEW BOATS AND BOATS THAT HAVE NEVER HAD A TIP BEFORE**

A temporary Import Permit is required for boats over 14.7 feet. You must be the owner of the vessel. Boats registered under a **family trust will not be accepted** even if your name is on the trust – the boat must be in the name of a person or company only.

If the boat is registered under a company name, you must present a letter of authorization on a company letterhead stating permission to take the boat into Mexico along with the Company "Articles of Corporation Document".

***This form must be submitted two weeks before date of entry and no more than 60 days prior.***

If the application is rejected for having an existing TIP you will be subject to a \$10 to \$25 handling fee.

**Payment:** Total is about \$100. **Visa or Mastercard ONLY.** Around \$1,175 pesos (\$52.20) will appear as a charge from México. There will also be a \$50 charge from Discover Baja for processing.
