Bahia De Los Angeles Art And Craft Show & Sale

The 14th Annual Bahia de los Angeles Art and Craft Show and Sale begins Sunday, March 24 and runs through Tuesday, April 2nd, at the Bahia de los Angeles Museum Salon. The show and sale will be held every day from 10:00 am- 4:00 pm.

A talented group of local artists will exhibit collections of oil, acrylic, and watercolor paintings, stunning gourd creations, beautifully crafted wooden objects, jewelry and fabric items. An opening reception—to which the public is invited—will be held on Sunday, March 24 , at 10:00 a.m.. Admission is free.

Mexico Increases Vehicle Accident Liability Benefits

As most of you know by now, Mexico passed a new law, which has significantly raised liability payments for vehicle accident deaths. Before, you could go anywhere in Mexico and \$50,000 was enough in your vehicle insurance policy to cover any death liability. Now the amounts have increased over seven times. AND.... amounts differ from state to state because of different minimum wages. So—if you drive only in the northern state of Baja (north of Guerrero Negro), a death liability claim could be as high as \$144,000, while in Baja Sur that jumps to \$336,000. In Mainland Mexico the amount can be as high as \$544,000.



Discover Baja now has insurance policies in place for purchase reflecting this new increase. ACE Seguros has added \$300,000 and \$500,000 CSL options for liability. Combined Single Limit is the amount available for any damage to property, things or people (including death). Be sure and check ACE's Platinum policy. In some cases you get more and pay less.

The other company we write for -- HDI Seguros – has increased the CSL options and also added an excess death liability feature. This coverage can be used only in case of a death. This all becomes a little clearer if you go to our web site www.discoverbaja.com and either renew or create a new policy. Mexico Supreme Court Rules in Favor of Same-sex Marriage

Mexico, interestingly enough, like the U.S., is also grappling with the issue of same-sex marriage. In an historic and unanimous decision last month, Mexico's Supreme Court ruled that denying same-sex couples in the Mexican State of Oaxaca the right to marry is unconstitutional and discriminatory, based in part on two old, but significant, U.S. Supreme Court decisions related to racial discrimination.

Justice Arturo Zaldívar Lelo de Larrea cited cases in Virginia and Kansas that laws banning interracial marriages, based solely on racial classifications, and laws requiring or permitting racial segregation in public schools violated the Equal Protection and Due Process clauses of the Fourteenth Amendment of the US Constitution.

Lelo de Larrea and his fellow jurists compared the racial discrimination in the U.S. cases to the discriminatory nature



of same-sex marriage bans, holding that such laws discriminate by depriving same-sex couples both of the right to marry and of the right to marital benefits.

In its ruling, the Mexican high court mandates that in accordance with principles of equality, the Oaxaca civil code must be written to describe marriage as between two people.

Mexico's legal system mandates that the high court must rule the same way in five separate cases before a law is overturned. This ruling concerns three separate cases; it will take two more for any same-sex couple in Oaxaca to be able to wed easily, and then the process may have to be repeated in other states of Mexico.

Daylight Savings Time in Baja



In California, Daylight Savings Time begins Sunday, March 10---so at 2:00 am, spring ahead one hour.

But unlike most states in the U.S., the state of Baja California (north of the 28th parallel) will not change to Daylight Savings Time until April 7th. The state of Baja California Sur (south of the 28th parallel) does not change to Daylight Savings Time.



I retained my card but the information from the card was stolen and someone attempted to use it in Mexicali on Feb. 10, 2013. Bank of America put a fraud alert out which prevented any other charges.

I guess it may not be safe to use charge cards at that Pemex station, and would recommend you pay by cash at that station or go elsewhere.
